As superintendent, I truly enjoy connecting with students, staff, families and community residents. In the weeks since the new school year began, I've taken time to visit schools, engage with students, cheer on our home teams, attend fall activities and connect with business, community and civic leaders.

#### WHY IS THE DISTRICT HOLDING A REFERENDUM?

We are seeking approval to renew the expiring capital projects levy approved in 2013 to continue to fund School Safety & Security that will better prepare for, protect against and respond to school emergencies and threats, and to support and maintain Education Technology for students and staff.

#### WHAT WILL THE MONEY BE USED FOR?

A safe learning environment is essential for all students to promote social and creative learning. We've significantly upgraded physical and security hardware, software, and training as part of a multi-layered approach to school safety. A renewal of the levy will enhance and expand security measures, including upgrades to alarm, video and emergency communications, and expanded training.

The Next Technologies for Learning plan shifted schools to one-to-one learning and put a structure in place to close the Digital Access Gap. Reinvestment is needed to expand anytime/anywhere learning solutions, improve classroom technology and digital learning platforms, and empower teachers with technology integration skills and tools.

# NOTICE OF SPECIAL ELECTION INDEPENDENT SCHOOL DISTRICT NO. 271 (BLOOMINGTON PUBLIC SCHOOLS) STATE OF MINNESOTA

NOTICE IS HEREBY GIVEN that a special election has been called and will be held in and for Independent School District No. 271 (Bloomington Public Schools), Minnesota, on November 8, 2022, between the hours of 7 a.m. and 8 p.m. to vote on the following question:

## School District Question Renewal of Expiring Capital Project Levy

The board of Independent School District No. 271 (Bloomington Public Schools), Minnesota has proposed to renew its capital project levy authorization expiring after taxes payable in 2023 in the maximum amount of 5.858% times the net tax capacity of the school district to provide funds for the acquisition, installation, support and maintenance of software and technology and the acquisition, installation, support and maintenance of safety and security improvements to school district facilities and equipment. The proposed tax rate is not being increased from the previous year's rate. The proposed renewal of the expiring capital project levy authorization will raise approximately \$9,810,844 for taxes first levied in 2023, payable in 2024, and will be authorized for ten (10) years. The estimated total cost of the projects to be funded over that time period is approximately \$98,108,440.

# HOW WILL THIS AFFECT PROPERTY TAXES?

The levy renewal can be accomplished with a no tax increase on property owners as a whole, unless property values increase in the future. If approved, the levy authorization at the current tax rate of 5.858 percent (net tax capacity of the district) will fund approximately \$9.8 million the first year (\$1,014 per student), and is renewed for 10 years, from 2025-2034.
