



Bloomington Drivers Education Program/A+ Driving School Summer 2024

Bloomington Driver's Education/A+ Driving School will be offering six **online** and two **in-person** classroom/behind-the-wheel packages this Summer for students who are **not signed up to take it as a credit during their regular school day schedule.** High school credits are **not** earned for these driver's education classes.

The total cost is \$420.00 for both the online & in-person "classroom & behind-the-wheel" packages. An \$80 registration fee is due when enrolling. Students may enroll if they are 14-1/2 years of age. For the online option: a few days before the class starts, the student will be sent a link for the class to the email address you provide. To pass the classroom portion, students must attend all 30 hours of instruction. The student will be given information about registering for the six hours of Behind-the-Wheel training with A+ Driving School, and will need to pay them \$145 to receive their blue card. Once the student receives their blue card, they may take their state permit exam at a DVS exam station (you must schedule an appointment--For a complete list of exam stations locations, go to: onlineservices.dps.mn.gov). The remainder of the payments to A+ Driving School can be paid at the time of the three Behind-the-Wheel lessons (\$65 per lesson).
